# SECTION 1 INSTRUCTION TO BIDDERS

			A. GENERAL
1.	Scope of the Bid	1.1	The Employer, as defined in the <b>Bidding Data Sheet (BDS)</b> , invites bids for the Services, as described in the Appendix A to the Contract. The name and identification number of the Contract is <b>provided in the BDS</b> .  The successful Bidder will be expected to complete the performance of the Services by the Intended Completion Date <b>provided in the BDS</b> .
2.	Source of Funds	2.1	The Employer guarantees that adequate public funds have been budgeted and allotted and are also available for managing the procurement proceedings toward the cost of the project <b>as specified in the BDS</b> . The Purchaser intends to apply a portion of the public funds <b>as identified in the BDS</b> , to eligible payments under the contract for which this Bidding Documents are issued.
		2.2	For the purpose of this provision, "PUBLIC FUNDS" defines any monetary resources appropriated to procuring entities under Government budget, or revenues generated by statutory bodies and corporations or aid grants and credits put at the disposal of procuring entities by the development partners through the Government.
3.	Eligible Bidders	3.1	This Invitation for Bids is open to all bidders from eligible countries.  Any materials, equipment, and Services to be used in the performance of the Contract shall have their origin in eligible source countries.
		3.2	All bidders shall provide in Section 3, Bidding Forms, a statement that the Bidder (including all members of a joint venture and subcontractors) is not associated, nor has been associated in the past, directly or indirectly, with the consultant or any other entity that has prepared the design, specifications, and other documents for the Project or being proposed as Project Manager for the Contract. A firm that has been engaged by the Procuring Entity to provide Consultant Services for the preparation or supervision of the Services, and any of its affiliates, shall not be eligible to bid.
		3.3	Government-owned enterprises in the Islamic Republic of Afghanistan may only participate if they are legally and financially autonomous, operate under commercial law, and are not a dependent agency of the Employer.
		3.4	It is strictly prohibited to make any withdrawal from the project budget for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the GoA, is prohibited by a decision of the United Nations Security Council, taken under Chapter VII of the Charter of the United Nations.

			(j)	Proposals for subcontracting components of the Services amounting to more than ten (10) percent of the Contract Price.

- 4.4 To qualify for award of the Contract, bidders shall meet the following minimum qualifying criteria:
  - (a) annual volume of Services of at least the amount **specified in the BDS**;
  - (b) experience as prime contractor in the provision of at least two (2) service contracts of a nature and complexity equivalent to the Services over the last five (5) years (to comply with this requirement, Services contracts cited should be at least seventy (70) percent complete) as specified in the BDS;
  - (c) proposals for the timely acquisition (own, lease, hire, etc.) of the essential equipment **listed in the BDS**;
  - (d) Contract Manager with five (5) years' experience in Services of an equivalent nature and volume, including no less than three years as Manager; and
  - (e) liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, of no less than the amount specified in the BDS.

A consistent history of litigation or arbitration awards against the Applicant or any partner of a Joint Venture may result in disqualification.

4.5 The figures for each of the partners of a joint venture shall be added together to determine the Bidder's compliance with the minimum qualifying criteria of ITB Sub-Clause 4.4(a), (b) and (e); however, for a joint venture to qualify the partner in charge must meet at least forty (40) percent of those minimum criteria for an individual Bidder and other

			partners at least twenty-five (25) percent of the criteria. Failure to		
			comply with this requirement will result in rejection of the joint venture's		
			Bid. Subcontractors' experience and resources will not be taken into		
			account in determining the Bidder's compliance with the qualifying		
			criteria, unless otherwise <b>stated in the BDS</b> .

The bidders' names, the Bid prices, the total amount of each Bid and of any alternative Bid (if alternatives have been requested or permitted), any discounts, Bid modifications and withdrawals, the presence or absence of Bid Security, and such other details as the Employer may consider appropriate, will be announced by the Employer at the opening. No bid shall be rejected at bid opening except for the late bids pursuant to ITB Clause 21; Bids, and modifications, sent pursuant to ITB Clause 22 that are not opened and read out at bid opening will not be considered for further evaluation regardless of the circumstances. Late and withdrawn bids will be returned unopened to the bidders. 23.4 The Employer will prepare minutes of the Bid opening, including the information disclosed to those present in accordance with ITB Sub-Clause 23.3. 24. Process to be Information relating to the examination, clarification, evaluation, and 24.1 Confidential comparison of bids and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process until the award to the successful Bidder is notified of the award. Any effort by a Bidder to influence the Employer's processing of bids or award decisions may result in the rejection of his Bid. 24.2 If, after notification of award, a bidder wishes to ascertain the grounds on which its bid was not selected, it should address its request to the Employer, who will provide written explanation. Any request for explanation from one bidder should relate only to its own bid; information about the bid of competitors will not be addressed. 25. Clarification 25.1 To assist in the examination, evaluation, and comparison of bids, the of Bids Employer may, at the Employer's discretion, ask any Bidder for clarification of the Bidder's Bid, including breakdowns of the prices in the Activity Schedule, and other information that the Employer may require. - (a) The Adjudicator is the person appointed jointly by the Employer and the Contractor to resolve disputes in the first instance, as provided for in Sub-Clause 8.2 hereunder.
- (b) "Activity Schedule" is the priced and completed list of items of Services to be performed by the Service Provider forming part of his Bid.
- (c) "Completion Date" means the date of completion of the Services by the Service Provider as certified by the Employer.
- (d) "Contract" means the Contract signed by the Parties, to which these General Conditions of Contract (GCC) are attached, together with all the documents listed in Clause 1 of such signed Contract.
- (e) "Contract Price" means the price to be paid for the performance of the Services, in accordance with Clause 6.
- (f) "Day works" means varied work inputs subject to payment on a time basis for the Service Provider's employees and equipment, in addition to payments for associated materials and administration.
- (g) "Employer" means the party who employs the Service Provider.
- (h) "Foreign Currency" means any currency other than the currency of the Islamic Republic of Afghanistan.
- (i) "GCC" means these General Conditions of Contract.
- (j) "Government" means the Government of the Islamic Republic of Afghanistan.
- (k) "Local Currency" means the currency of the Islamic Republic of Afghanistan.
- (I) "Member," in case the Service Provider consist of a joint venture of more than one entity, means any of these entities; "Members" means all these entities, and
