## SECTION 1 INSTRUCTION TO BIDDERS

A. GENERAL	
<b>1. Scope of the Bid</b>	1.1 The Employer, as defined in the <b>Bidding Data Sheet (BDS)</b> , invites bids for the Services, as described in the Appendix A to the Contract. The name and identification number of the Contract is <b>provided in the BDS</b> .
	1.2 The successful Bidder will be expected to complete the performance of the Services by the Intended Completion Date <b>provided in the BDS</b> .
<b>2. Source of Funds</b>	2.1 The Employer guarantees that adequate public funds have been budgeted and allotted and are also available for managing the procurement proceedings toward the cost of the project <b>as specified in the BDS</b> . The Purchaser intends to apply a portion of the public funds <b>as identified in the BDS</b> , to eligible payments under the contract for which this Bidding Documents are issued.
	2.2 For the purpose of this provision, “PUBLIC FUNDS” defines any monetary resources appropriated to procuring entities under Government budget, or revenues generated by statutory bodies and corporations or aid grants and credits put at the disposal of procuring entities by the development partners through the Government.
<b>3. Eligible Bidders</b>	3.1 This Invitation for Bids is open to all bidders from eligible countries. Any materials, equipment, and Services to be used in the performance of the Contract shall have their origin in eligible source countries.
	3.2 All bidders shall provide in Section 3, Bidding Forms, a statement that the Bidder (including all members of a joint venture and subcontractors) is not associated, nor has been associated in the past, directly or indirectly, with the consultant or any other entity that has prepared the design, specifications, and other documents for the Project or being proposed as Project Manager for the Contract. A firm that has been engaged by the Procuring Entity to provide Consultant Services for the preparation or supervision of the Services, and any of its affiliates, shall not be eligible to bid.
	3.3 Government-owned enterprises in the Islamic Republic of Afghanistan may only participate if they are legally and financially autonomous, operate under commercial law, and are not a dependent agency of the Employer.
	3.4 It is strictly prohibited to make any withdrawal from the project budget for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the GoA, is prohibited by a decision of the United Nations Security Council, taken under Chapter VII of the Charter of the United Nations.
	3.5 Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by the Islamic Republic of Afghanistan in

	accordance with ITB Sub-Clause 37.1
<b>4. Qualification of the Bidder</b>	4.1 All bidders shall provide in Section 3, Bidding Forms, a preliminary description of the proposed work method and schedule, including drawings and charts, as necessary.
	<p>4.2 All bidders shall include the following information and documents with their bids in Section 3, unless otherwise stated in the <b>BDS</b>:</p> <ul style="list-style-type: none"> <li>(a) copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder;</li> <li>(b) total monetary value of Services performed for any of the last five (5) years;</li> <li>(c) experience in Services of a similar nature and size for any of the last five (5) years, and details of Services under way or contractually committed; and names and address of clients who may be contacted for further information on those contracts;</li> <li>(d) list of major items of equipment proposed to carry out the Contract;</li> <li>(e) qualifications and experience of key site management and technical personnel proposed for the Contract;</li> <li>(f) reports on the financial standing of the Bidder, such as profit and loss statements and auditor's reports for the past five (5) years;</li> <li>(g) evidence of adequacy of working capital for this Contract (access to line(s) of credit and availability of other financial resources);</li> <li>(h) authority to the Employer to seek references from the Bidder's bankers;</li> <li>(i) information regarding any litigation, current or during the last five (5) years, in which the Bidder is involved, the parties concerned, and disputed amount; and</li> <li>(j) Proposals for subcontracting components of the Services amounting to more than ten (10) percent of the Contract Price.</li> </ul>
	<p>4.3 Bids submitted by a joint venture of two (2) or more firms as partners shall comply with the following requirements, unless otherwise stated in the <b>BDS</b>:</p> <ul style="list-style-type: none"> <li>(a) the Bid shall include all the information listed in ITB Sub-Clause 4.2 above for each joint venture partner;</li> <li>(b) the Bid shall be signed so as to be legally binding on all partners;</li> <li>(c) the Bid shall include a copy of the agreement entered into by the joint venture partners defining the division of assignments to each</li> </ul>

	<p>partner and establishing that all partners shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms;</p> <p>(d) one (1) of the partners shall be nominated as being in charge, authorized to incur liabilities, and receive instructions for and on behalf of any and all partners of the joint venture; and</p> <p>(e) the execution of the entire Contract, including payment, shall be done exclusively with the partner in charge.</p>
	<p>4.4 To qualify for award of the Contract, bidders shall meet the following minimum qualifying criteria:</p> <p>(a) annual volume of Services of at least the amount <b>specified in the BDS</b>;</p> <p>(b) experience as prime contractor in the provision of at least two (2) service contracts of a nature and complexity equivalent to the Services over the last five (5) years (to comply with this requirement, Services contracts cited should be at least seventy (70) percent complete) <b>as specified in the BDS</b>;</p> <p>(c) proposals for the timely acquisition (own, lease, hire, etc.) of the essential equipment <b>listed in the BDS</b>;</p> <p>(d) Contract Manager with five (5) years' experience in Services of an equivalent nature and volume, including no less than three years as Manager; and</p> <p>(e) liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, of no less than the amount specified in the <b>BDS</b>.</p> <p>A consistent history of litigation or arbitration awards against the Applicant or any partner of a Joint Venture may result in disqualification.</p>
	<p>4.5 The figures for each of the partners of a joint venture shall be added together to determine the Bidder's compliance with the minimum qualifying criteria of ITB Sub-Clause 4.4(a), (b) and (e); however, for a joint venture to qualify the partner in charge must meet at least forty (40) percent of those minimum criteria for an individual Bidder and other partners at least twenty-five (25) percent of the criteria. Failure to comply with this requirement will result in rejection of the joint venture's Bid. Subcontractors' experience and resources will not be taken into account in determining the Bidder's compliance with the qualifying criteria, unless otherwise <b>stated in the BDS</b>.</p>
<p><b>5. One Bid per</b></p>	<p>5.1 Each Bidder shall submit only one (1) Bid, either individually or as a partner in a joint venture. A Bidder who submits more than one (1) Bid</p>

<b>Bidder</b>	(other than as a subcontractor or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Bidder's participation to be disqualified.
<b>6. Cost of bidding</b>	6.1 The Bidder shall bear all costs associated with the preparation and submission of his Bid, and the Employer will in no case be responsible or liable for those costs.
<b>7. Site Visit</b>	7.1 The Bidder, at the Bidder's own responsibility and risk, is encouraged to visit and examine the Site of required Services and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the Services. The costs of visiting the Site shall be at the Bidder's own expense.
<b>B. BIDDING DOCUMENTS</b>	
<b>8. Content of Bidding Documents</b>	<p>8.1 The set of bidding documents comprises the documents listed in the table below and addenda issued in accordance with ITB Clause 10:</p> <p>Section 1 Instructions to Bidders</p> <p>Section 2 Bidding Data Sheet</p> <p>Section 3 Bidding Forms</p> <p>Section 4 Eligible Countries</p> <p>Section 5 Activity Schedule</p> <p>Section 6 General Conditions of Contract</p> <p>Section 7 Special Conditions of Contract</p> <p>Section 8 Performance Specifications and Drawings (if applicable)</p> <p>Section 9 Contract Forms</p>
	8.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or to submit a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in the rejection of its bid. Sections 3, 5, and 9 should be completed and returned with the Bid in the number of copies specified in the <b>BDS</b> .
<b>9. Clarification of Bidding Documents</b>	9.1 A prospective Bidder requiring any clarification of the bidding documents may notify the Employer in writing or by email at the Employer's address indicated in the invitation to bid. The Employer will respond to any request for clarification received earlier than Seven (7) days prior to the deadline for submission of bids. Copies of the Employer's response will be forwarded to all purchasers of the bidding documents, including a description of the inquiry, but without identifying its source.
<b>10. Amendment of</b>	10.1 Before the deadline for submission of bids, the Employer may modify the



<b>Bidding Documents</b>	bidding documents by issuing addenda.
	10.2 Any addendum thus issued shall be part of the bidding documents and shall be communicated in writing or by email to all purchasers of the bidding documents. Prospective bidders shall acknowledge receipt of each addendum by email to the Employer.
	10.3 To give prospective bidders reasonable time in which to take an addendum into account in preparing their bids, the Employer shall extend, as necessary, the deadline for submission of bids, in accordance with ITB Sub-Clause 20.2 below.
<b>C. PREPARATION OF BIDS</b>	
<b>11. Language of the Bid</b>	11.1 The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the Employer shall be written in the language <b>specified in the BDS</b> . Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant passages in the language specified in the Bidding Data Sheet, in which case, for purposes of interpretation of the Bid, the translation shall govern.
<b>12. Document Comprising the Bid</b>	12.1 The Bid submitted by the Bidder shall comprise the following: <ul style="list-style-type: none"> <li>(a) The Form of Bid (in the format indicated in Section 3);</li> <li>(b) Bid Security;</li> <li>(c) Priced Activity Schedule;</li> <li>(d) Qualification Information Form and Documents;</li> <li>(e) Alternative offers where invited; and</li> <li>(f) Any other materials required to be completed and submitted by bidders, as <b>specified in the BDS</b>.</li> </ul>
	12.2 Bidders bidding for this contract together with other contracts stated in the IFB to form a package will so indicate in the bid together with any discounts offered for the award of more than one contract.
<b>13. Bid Prices</b>	13.1 The Contract shall be for the Services, as described in Appendix A to the contract and in the Specifications, Section 8, based on the priced Activity Schedule, Section 5, submitted by the Bidder.
	13.2 The Bidder shall fill in rates and prices for all items of the Services described in the in Specifications (or Terms of Reference), Section 8 and listed in the Activity Schedule, Section 5. Items for which no rate or price is entered by the Bidder will not be paid for by the Employer when executed and shall be deemed covered by the other rates and prices in the Activity Schedule.
	13.3 All duties, taxes, and other levies payable by the Service Provider

	under the Contract, or for any other cause, as of the date twenty-eight (28) days prior to the deadline for submission of bids, shall be included in the total Bid price submitted by the Bidder.
	13.4 If <b>provided for in the BDS</b> , the rates and prices quoted by the Bidder shall be subject to adjustment during the performance of the Contract in accordance with and the provisions of Clause 6.6 of the General Conditions of Contract and/or Special Conditions of Contract. The Bidder shall submit with the Bid all the information required under the Special Conditions of Contract and of the General Conditions of Contract.
	13.5 For the purpose of determining the remuneration due for additional Services, a breakdown of the lump-sum price shall be provided by the Bidder in the form of Appendices D and E to the Contract.
<b>14. Currencies of Bid and Payment</b>	14.1 The lump sum price shall be quoted by the Bidder separately in the following currencies: <ul style="list-style-type: none"> <li>(a) for those inputs to the Services which the Bidder expects to provide from within the Employer's country, the prices shall be quoted in the currency of the Employer's country, unless otherwise <b>specified in the BDS</b>; and</li> <li>(b) for those inputs to the Services which the Bidder expects to provide from outside the Employer's country, the prices shall be quoted in up to any three currencies of international use.</li> </ul>
	14.2 Bidders shall indicate details of their expected foreign currency requirements in the Bid.
	14.3 Bidders may be required by the Employer to justify their foreign currency requirements and to substantiate that the amounts included in the Lump Sum are reasonable and responsive to ITB Sub-Clause 14.1.
<b>15. Bid Validity</b>	15.1 Bids shall remain valid for the period <b>specified in the BDS</b> .
	15.2 In exceptional circumstances, the Employer may request that the bidders extend the period of validity for a specified additional period. The request and the bidders' responses shall be made in writing or by email. A Bidder may refuse the request without forfeiting the Bid Security. A Bidder agreeing to the request will not be required or permitted to otherwise modify the Bid, but will be required to extend the validity of Bid Security for the period of the extension, and in compliance with ITB Clause 16 in all respects.
	15.3 In the case of contracts in which the Contract Price is fixed (not subject to price adjustment), if the period of bid validity is extended by more than sixty (60) days, the amounts payable in local and foreign currency to the Bidder selected for award, shall be increased by applying to both the local and the foreign currency component of the

	<p>payments, respectively, the factors specified in the request for extension, for the period of delay beyond sixty (60) days after the expiry of the initial bid validity, up to the notification of award. Bid evaluation will be based on the Bid prices without taking the above correction into consideration.</p>
<b>16. Bid Security</b>	<p>16.1 The Bidder shall furnish, as part of the Bid, a Bid Security or a Bid-Securing Declaration, if required, as <b>specified in the BDS</b>.</p>
	<p>16.2 The Bid Security shall be in the amount <b>specified in the BDS</b> and denominated in the currency of the Employer's Country or a freely convertible currency, and shall:</p> <ul style="list-style-type: none"> <li>(a) In cash, or at the bidder's option, be in the form of either a letter of credit, or a bank guarantee from a banking institution;</li> <li>(b) be issued by a reputable institution selected by the bidder and located in any eligible country;</li> <li>(c) be substantially in accordance with one of the forms of Bid Security included in Section 9, Contract Forms, or other form approved by the Employer prior to bid submission;</li> <li>(d) be payable promptly upon written demand by the Employer in case the conditions listed in ITB Sub-Clause 16.5 are invoked;</li> <li>(e) be submitted in its original form; copies will not be accepted;</li> <li>(f) remain valid for a period of twenty-eight (28) days beyond the validity period of the bids, as extended, if applicable, in accordance with ITB Sub-Clause 15.2.</li> </ul>
	<p>16.3 If a Bid Security or a Bid- Securing Declaration is required in accordance with ITB Sub-Clause 16.1, any bid not accompanied by a substantially responsive Bid Security or Bid Securing Declaration in accordance with ITB Sub-Clause 16.1, shall be rejected by the Employer as non-responsive.</p>
	<p>16.4 The Bid Security of unsuccessful Bidders shall be returned as promptly as possible upon the successful Bidder's furnishing of the Performance Security pursuant to ITB Clause 34.</p>
	<p>16.5 The Bid Security may be forfeited or the Bid Securing Declaration executed:</p> <ul style="list-style-type: none"> <li>(a) if a Bidder withdraws its bid during the period of bid validity specified by the Bidder on the Bid Submission Form, except as provided in ITB Sub-Clause 15.2; or</li> <li>(b) if a Bidder refuses to accept a correction of an arithmetical error appearing on the face of the bid;</li> <li>(c) if a Bidder had provided bogus information about his/her</li> </ul>

	<p>eligibility;</p> <p>(d) if the successful Bidder fails to:</p> <p>(i) sign the Contract in accordance with ITB Clause 33;</p> <p>(ii) furnish a Performance Security in accordance with ITB Clause 34.</p>
	<p>16.6 The Bid Security or Bid- Securing Declaration of a JV must be in the name of the JV that submits the bid. If the JV has not been legally constituted at the time of bidding, the Bid Security or Bid-Securing Declaration shall be in the names of all future partners as named in the letter of intent to constitute the JV.</p>
<b>17. Alternative Proposals by Bidders</b>	<p>17.1 <b>Unless otherwise indicated in the BDS</b>, alternative bids shall not be considered.</p>
	<p>17.2 When alternative times for completion are explicitly invited, a statement to that effect will be <b>included in the BDS</b>, as will the method of evaluating different times for completion.</p>
	<p>17.3 Except as provided under ITB Sub-Clause 17.4 below, bidders wishing to offer technical alternatives to the requirements of the bidding documents must first submit a Bid that complies with the requirements of the bidding documents, including the scope, basic technical data, graphical documents and specifications. In addition to submitting the basic Bid, the Bidder shall provide all information necessary for a complete evaluation of the alternative by the Employer, including calculations, technical specifications, breakdown of prices, proposed work methods and other relevant details. Only the technical alternatives, if any, of the lowest evaluated Bidder conforming to the basic technical requirements shall be considered by the Employer. Alternatives to the specified performance levels shall not be accepted.</p>
	<p>17.4 When bidders are <b>permitted in the BDS</b> to submit alternative technical solutions for specified parts of the Services, such parts shall be described in the Specifications (or Terms of Reference) and Drawings, Section 8. In such case, the method for evaluating such alternatives will be as <b>indicated in the BDS</b>.</p>
<b>18. Format and Signing of Bid</b>	<p>18.1 The Bidder shall prepare one original of the documents comprising the Bid as described in ITB Clause 12 of these Instructions to Bidders, bound with the volume containing the Form of Bid, and clearly marked "ORIGINAL". In addition, the Bidder shall submit copies of the Bid, in the number <b>specified in the BDS</b>, and clearly marked as "COPIES". In the event of discrepancy between them, the original shall prevail.</p>
	<p>18.2 The original and all copies of the Bid shall be typed or written in indelible ink and shall be signed by a person or persons duly</p>

	<p>authorized to sign on behalf of the Bidder, pursuant to Sub-Clauses 4.2(a) or 4.3(b), as the case may be. All pages of the Bid where entries or amendments have been made shall be initialed by the person or persons signing the Bid.</p>
	<p>18.3 The Bid shall contain no alterations or additions, except those to comply with instructions issued by the Employer, or as necessary to correct errors made by the Bidder, in which case such corrections shall be initialed by the person or persons signing the Bid.</p>
<b>D. SUBMISSION OF BIDS</b>	
<b>19. Sealing and Marking the Bids</b>	<p>19.1 The Bidder shall seal the original and all copies of the Bid in two inner envelopes and one outer envelope, duly marking the inner envelopes as “ORIGINAL” and “COPIES”.</p>
	<p>19.2 The inner and outer envelopes shall:</p> <ul style="list-style-type: none"> <li>(a) be addressed to the Employer at the address <b>provided in the BDS</b>;</li> <li>(b) bear the name and identification number of the Contract as <b>defined in the BDS</b> and Special Conditions of Contract; and</li> <li>(c) provide a warning not to open before the specified time and date for Bid opening as <b>defined in the BDS</b>.</li> </ul>
	<p>19.3 In addition to the identification required in ITB Sub-Clause 19.2, the inner envelopes shall indicate the name and address of the Bidder to enable the Bid to be returned unopened in case it is declared late, pursuant to ITB Clause 21.</p>
	<p>19.4 If the outer envelope is not sealed and marked as above, the Employer will assume no responsibility for the misplacement or premature opening of the Bid.</p>
<b>20. Deadline for submission of Bids</b>	<p>20.1 Bids shall be delivered to the Employer at the address specified above no later than the time and date <b>specified in the BDS</b>.</p>
	<p>20.2 The Employer may extend the deadline for submission of bids by issuing an amendment in accordance with ITB Clause 10, in which case all rights and obligations of the Employer and the bidders previously subject to the original deadline will then be subject to the new deadline.</p>
<b>21. Late Bids</b>	<p>21.1 Any Bid received by the Employer after the deadline prescribed in ITB Clause 20 will be returned unopened to the Bidder.</p>
<b>22. Modification and Withdrawal of Bid</b>	<p>22.1 Bidders may modify or withdraw their bids by giving notice in writing before the deadline prescribed in ITB Clause 20.</p>
	<p>22.2 Each Bidder’s modification or withdrawal notice shall be prepared, sealed, marked, and delivered in accordance with ITB Clauses 18 and 19,</p>

	with the outer and inner envelopes additionally marked “MODIFICATION” or “WITHDRAWAL”, as appropriate.
	22.3 No Bid may be modified after the deadline for submission of Bids.
	22.4 Withdrawal of a Bid between the deadline for submission of bids and the expiration of the period of Bid validity specified in the BDS or as extended pursuant to ITB Sub-Clause 15.2 may result in the forfeiture of the Bid Security pursuant to ITB Clause 16.
	22.5 Bidders may only offer discounts to, or otherwise modify the prices of their bids by submitting Bid modifications in accordance with this clause, or included in the original Bid submission.
<b>E. BID OPENING AND EVALUATION</b>	
<b>23. Bid Opening</b>	23.1 The Employer will open the bids, including modifications made pursuant to ITB Clause 22, in the presence of the bidders’ representatives who choose to attend at the time and in the place <b>specified in the BDS</b> .
	23.2 Envelopes marked “WITHDRAWAL” shall be opened and read out first. Bids for which an acceptable notice of withdrawal has been submitted pursuant to ITB Clause 22 shall not be opened.
	23.3 The bidders’ names, the Bid prices, the total amount of each Bid and of any alternative Bid (if alternatives have been requested or permitted), any discounts, Bid modifications and withdrawals, the presence or absence of Bid Security, and such other details as the Employer may consider appropriate, will be announced by the Employer at the opening. ### **I. Introduction:**

Afghan Telecom intends to acquire an international voice carrier to comply with Afghan Telecom and SALAAM international voice traffic.

### **II. Background:**

Voice carriers are companies who carry and bring international voice calls from and to operators' premises, Carrier is paid the amount for the traffic the operators is sending to them, and the carrier is charged for the traffic they are sending to the operator, the Operator (salaam) connects to the carrier HUB and through that HUB traffic is sent and received, at the end of each month settlement of traffic take place after Balancing and sharing the traffic report reconciliation takes place.

For SALAAM and Afghan Telecom customers to make and receive calls the traffic is carried by carriers, as carriers have multi connections to and from their HUBs.

### **III. Overview**

#### **A. Project Objective:**

The Voice Carrier will enable SALAAM and Afghan Telecom to carry its traffic to the world's destination and also to collect traffic from different destinations around the world. SALAAM and AFTEL will be paying per-minute costs to carriers and carriers will be paying per minute to Salaam for inbound traffic.

Without Voice carriers, SALAAM and Afghan Telecom would not be able to call to international destinations and also will be not able to receive calls from international destinations.

### **IV. Responsibility Matrix:**

This section specifies the information and responsibilities between Operator (Afghan Telecom and Salaam) and Voice carrier (Service Provider) for originating and terminating International voice.

The Responsibility Matrix states different areas of activities within the project and clarifies the division of responsibility between both parties.

**D. Facilities provided by Afghan Telecom:**

- Afghan Telecom shall connect the carriers to their international gateway.
- Afghan Telecom shall allow the carrier to send and receive the traffic to and from their network.
- Afghan Telecom shall provide their traffic report for monthly reconciliation and CDR in case of any dispute.
- AFTEL will provide its rates which will be charged on the incoming minute.
- AFTEL has IGW (International Gateway) to connect carriers to them.
- AFTEL has IMS (IP Multimedia System) for Fix line traffic, Carrier could be connected to fix traffic via IGW.

**E. Bid Evaluation:**

- Afghan Telecom will select at least 3 qualified carriers for signing the contract.
- Afghan Telecom will ask carriers for rates for all destinations one week ago before the start of every month, AFTEL will route traffic to the carrier which offers the best rate and quality to the specific destination.

**F. Taxation:**

**G. Contract Cancel terms:**

- AFTEL can cancel the contract with the bidder if not implemented on time.

- If the Service Provider failed to collect the traffic from the traffic sent region through the carrier, SALAAM has the right to hire another carrier.
- If the Service Provider failed to provide competitive rates and quality for outgoing traffic SALAAM will route the traffic to another carrier.
- If the carrier found during testing to send CLI calls on Non-CLI route the carrier will be given notices, in case of not solving the issue in the specific time given the breach of agreement will happen and AFTEL have the right to terminate the contract.

**H. Term: Renewal:**

The term of this agreement shall commence on the Effective Date and it will continue for three (3) years. after the initial term, AFTEL will extend the contract as per the requirement on a semiannual basis (Six months). The term "Term" as used herein refers to the initial and any renewal thereof. #### **Project Implementation:**

The carriers shall be connected for at least 3 years. Afghan Telecom needs the carriers to be connected at the earliest after signing the contract in order to start international call flow through hired carriers.

#### **Payments:**

- AFTEL will not pay the monthly/recurring or invoices, one time or any revenue shared amount to the bidder if they failed to supply the services within the given time frame
